## **Load Management Value**

Polk County Rural Public Power District's system peak (kW) always hits during the summer months, when the irrigation load is at its highest. When we begin load management, we can reduce that peak kW. The lower our peak kW demand, the lower our power bill from our supplier, Nebraska Public Power District (NPPD). In a typical irrigation season, our average load management kW demand reduction is over 14,000 kW, resulting in an average power cost savings of over \$800,000.

Load management season operates June 1st-September 15th. NPPD determines hours of control each day, and PCRPPD controls according to their directive. Possible control hours are 9:00 AM - 11:00 PM, with actual control hours not exceeding 12 hours per day. Control on Sundays is limited to six hours and a maximum of 72 hours per week.

In 2022, PCRPPD introduced a new 6 1/2 Day Control rate, our most economical offering. The more often the customer allows us to shed their load, the deeper the horsepower and energy discounts. In 2024, to encourage you to try our new rate, we will waive the Control Rate Service Charge of \$60 if you change to the 6 1/2 Day rate and it doesn't work for your well.

# Help Us Help You

When calling PCRPPD to report an outage, please know your well number, meter number or account number. The meter number can be found on the face of the meter. The well number will be marked by a silver tag on the meter pole or written on meter side. Knowing this will help us more quickly restore outages.



# NOTES

Bypassing or tampering with the control device will result in removal from load control and a fine. Please contact the office if work is done on your service affecting our load control device. Service owners will be responsible for notifying PCRPPD.

Every effort will be made to suspend control in the event of service repair, but it cannot be guaranteed. Please plan maintenance around your control days/hours.

If spraying has taken place on your fields, please let us know. Many applications have a waiting period for entry and can be harmful to our linemen.

Capacitors are required on all non-VFD motors over 10HP. Penalties will be applied each irrigation season until installed.

A path to our control device is required. Please ensure there is access to the load control device.
