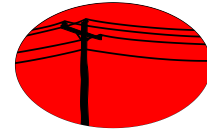


COUNTY RURAL PUBLIC POWER DISTRICT

General Service – Single & Three Phase

AVAILABLE: In the Urban areas served by Polk County Rural Public Power District.

APPLICABLE: To single or three phase commercial services that may be served from existing distribution lines.

CHARACTER OF SERVICE: 60 cycle, AC, single or three phase at any of the District’s standard voltages.

RATE:

SEASONAL BILLING PERIODS:

Summer – Billing periods June through September

Winter – Billing periods October through May

MINIMUM BILL: The minimum bill shall be the monthly Customer Service Charge.

POWER FACTOR ADJUSTMENT: The rates set forth in this schedule are based on the maintenance by the customer of a power factor of not less than 90% at all times. If it is determined by test that the power factor at the time of the customer’s peak load is less than 90%, the District, at its option, may correct the power factor of the customer’s load at the expense of the customer.

FLUCTUATING LOADS: Customers operating equipment having a highly fluctuating or large instantaneous demand, such as welders and x-ray machines, shall be required to pay all non-betterment costs of isolating the load from the balance of the District’s system so that the load will not unduly interfere with service on the District’s lines. In addition, customers who fail to provide adequate corrective equipment shall be required to own and maintain their own transformers.

TERMS OF PAYMENT: Bills for all services shall be due upon receipt and delinquent upon the date noted on the bill. Delinquent accounts will be charged a Late Fee of \$10.00 per occurrence for any amount greater than \$30.00, plus 1.33% per month or 15.96% per annum on the unpaid amount until the bill is paid in full.

BASE RATE ADJUSTMENT:

Customers who are served from distribution facilities for which the District has a Lease Payment (LP) or Debt Service (DS) obligation and/or a 5% Gross Revenue Tax (GRT) obligation will have the Base Rate (excluding PCA) adjusted to include such obligations as shown below:

Applicable Adjustment	Rate Formula
None	Base Rates
Lease Payment (LP) or Debt Service (DS) Only	Base Rates ÷ 0.88
LP/DS and Gross Revenue Tax (GRT)	Base Rates ÷ 0.83

TERMS AND CONDITIONS:

1. Service will be furnished under the District's General Terms and Conditions as provided in contracts for service under this schedule.
2. Extensions made for service under this schedule are subject to the provisions of the District's rules governing Extension of Service and Facilities.

The rates herein provided are subject to modifications by the District to reflect wholesale power rate adjustments and other changes in costs to the District after giving notice to the customers.
