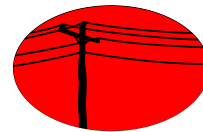

**IRRIGATION – SINGLE & THREE PHASE  
WEEKLY CONTROL-TWO DAYS OF THE WEEK**

**AVAILABLE:** In the general area served by Polk County Rural Public Power District.

**APPLICABLE:** To year-round irrigation services for customers who will contract for a minimum of five (5) horsepower for five (5) years and who may be served from existing distribution lines.

**CHARACTER OF SERVICE:** 60 cycle, AC, single or three phase at any of the District’s standard voltages of 12,470 volts or less.

**RATE:**

**Fixed Charges**

Monthly Customer Charge – \$65.75 - Single Phase  
Per billable months of July, August, September and October

Monthly Customer Charge – \$72.00 – Three Phase  
Per billable months of July, August, September and October

Annual Horsepower Charge \$42.80  
Per horsepower connected per year billable in April

**Energy Charge** \$0.08950 per kWh used  
Per billable months of July, August, September and October

**MINIMUM BILL:** The minimum bill shall be the sum of the monthly customer charge and the annual horsepower charge.

**DETERMINATION OF CONNECTED LOAD:** The connected load in horsepower shall be taken from an actual measurement of horsepower input to the motor operating under maximum load conditions. The District reserves the right at any time to check the customer’s load for recalculation of the minimum bill.

**USE OF SERVICE FOR PURPOSES OTHER THAN IRRIGATION:** At locations where the District has provided facilities for irrigation service, the customer may use the facilities for purposes other than irrigation provided such service may be supplied from the District’s facilities serving the irrigation pump.

**TERMS OF PAYMENT:** The horsepower charge will be billed in April of each year, is due upon receipt and delinquent June 10<sup>th</sup>. Energy charge and the monthly customer charge will be billed during the irrigation season in July, August, September and October, is due upon receipt and delinquent if not paid by the due date stated on the bill. Delinquent accounts will be charged a Late Fee of \$10.00 per occurrence for any amount greater than \$30.00, plus 1.33% per month or 15.96% per annum on the unpaid amount until the bill is paid in full.

**TERMS AND CONDITIONS:**

The rates herein provided are subject to modifications by the District to reflect wholesale power rate adjustments and other changes in costs to the District after giving notice to the customers.
