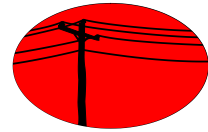

**IRRIGATION – SINGLE & THREE PHASE
TWO-DAY WEEKLY CONTROL**

AVAILABLE: In the general area served by Polk County Rural Public Power District.

APPLICABLE: To year-round irrigation services for customers who will contract for a minimum of five (5) horsepower (single phase) or 15 horsepower (three phase) for a minimum five (5) years and who may be served from existing distribution lines.

CHARACTER OF SERVICE: 60 cycle, AC, single or three phase at any of the District standard voltages of 12,470 volts or less.

RATE:

Fixed Charges

Monthly Customer Charge per Summer billing periods June through September
\$79.50 - Single Phase
\$87.00 – Three Phase

Annual Horsepower Charge \$45.80
Per horsepower connected per year billable in April

Energy Charge

Billing periods June through November
\$0.09077 per kWh

MINIMUM BILL: The minimum bill shall be the sum of the monthly customer charge and the annual horsepower charge.

DETERMINATION OF CONNECTED HP: The connected load in horsepower shall be the maximum demand established by the customer for any 15-minute period. The District reserves the right at any time to check the demand for recalculation of the minimum bill or use previous HP calculations.

USE OF SERVICE FOR PURPOSES OTHER THAN IRRIGATION: At locations where the District has provided facilities for irrigation service, the customer may use the facilities for purposes other than irrigation provided such service may be supplied from the District’s facilities serving the irrigation pump.

TERMS OF PAYMENT: The horsepower charge will be billed in April of each year, is due upon receipt and delinquent June 10th. Energy charge and the monthly customer charge will be billed during the irrigation season in July, August, September and October and energy only in December. Bills are due upon receipt and delinquent if not paid by the due date stated on the bill. Delinquent accounts will be charged a Late Fee of \$10.00 per occurrence for any amount greater than \$30.00, plus 1.33% per month or 15.96% per annum on the unpaid amount until the bill is paid in full.

TERMS AND CONDITIONS:

1. Service will be furnished under the District General Terms and Conditions and special terms and conditions as provided in contracts for service under this schedule.

The rates herein provided are subject to modifications by the District to reflect wholesale power rate adjustments and other changes in costs to the District after giving notice to the customers.
