**Automated Telephone or Recorded Message Consent Form**

The Telephone Consumer Protection Act (TCPA) regulates telemarketing calls, auto-dialed calls, prerecorded calls, text messages, and unsolicited faxes. It also is the authority to create the National Do-Not-Call List. The Federal Communications Commission ("FCC") is empowered to issue rules and regulations implementing the TCPA.

Although PCRPPD is committed to informing its customers and the general public to any condition which may affect the safety, reliability, and expense of their electrical service, or for any other reason relevant to their electrical service, we cannot use automatic means to do so without your permission. By selecting a permissible contact method and the type of information you desire, and by signing this form, you agree to allow PCRPPD personnel to contact you via prerecorded voice calls, autodialed calls or by text message concerning account billing or service information.
