

This achievement sets Nebraska apart and underscores the state's dedication to providing affordable, reliable energy while supporting local communities.

#### 100% Public Power

Nebraska's unique status as the sole state with 100% public power is a testament to its long-standing commitment to serving its residents. Public power means that the generation, transmission, and distribution of electricity are all in the hands of publicly owned utilities, ensuring that decisions are made with the community's best interests in mind.

Public power utilities in Nebraska operate under the guiding principles of affordability, reliability, and community service. These principles have allowed the state to maintain competitive electricity rates while ensuring the lights stay on when needed.

#### **Local Representation**






not just professional but also personal, which drives them to make decisions that benefit their neighbors and local businesses.
