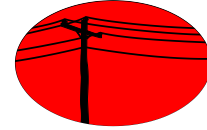

RESIDENTIAL & COMMERCIAL - SINGLE PHASE

AVAILABLE: In the general area served by Polk County Rural Public Power District.

APPLICABLE: To single phase residential or commercial services that may be served from existing distribution lines. Single phase motors shall not exceed ten (10) horsepower individual rating.

CHARACTER OF SERVICE: 60 cycle, AC, single phase at any of the District's standard voltages of 7,200 volts or less.

Effective billing period: June through September \$0.0791 per kWh used

Effective billing period: October through May \$0.0645 per kWh used

MINIMUM BILL: The minimum bill shall be the sum of the monthly customer service charge and monthly demand charge.

TERMS OF PAYMENT: Bills for all services shall be due upon receipt and delinquent upon the date noted on the bill. Delinquent accounts will be charged a Late Fee of \$10.00 per occurrence for any amount greater than \$30.00, plus 1.33% per month or 15.96% per annum on the unpaid amount until the bill is paid in full.
